

The Duopoly is over! UPS and FedEx set their own stage to invite competition, during Covid, they had massive increases in volume and revenue they were eager to report. A big mistake, eliminating the service guarantees on air and ground packages, the air guarantees came back, the ground did not. Ground services in the days before Covid had a day guarantee not a time of day. They created a "Delivery Patience"; this "Delivery Patience" was the catalyst to an evolving crowd sourced delivery methodology looking for an entrance. Local crowd sourced packages, created a cost structure where UPS and FedEx cannot compete. They will be able to compete, but not in the near future. New Union Contracts pay drivers where the delivery density per driver is becoming out of reach. Local carriers can optimize network capacities based on "Delivery Patience".

There are so many ways to get a package these days, you can even "ship to store", if you have to go out for milk. UPS and FedEx are prepared to increase shareholder value by "buying your business", they will not be concerned in the next few years with "package profitability", but "package retention". Package retention is the play to hypnotize shareholders, until they can figure out where they stand in the new era of parcel management.

Over my last twenty-six years in this business, I have never seen such a buyer's market. UPS and FedEx were at less than capacity during the holiday season for the second year in a row. Less than seventy percent (-70%) to be clear.

The USPS recently declared they were no longer offering a parcel select program for UPS and FedEx; creating an increased cost for residential deliveries in particular. This translates to volume that may shifted easily to TEMU, Amazon, Uni-Uni, well-established regional carriers, and the like.

Customer shopping habits have changed so rapidly, the "authenticity of enhanced virtual product experiences" will continue the "crowd sourced ground swell" of package delivery moving forward.

The self-inflicted vacuum UPS and FedEx created during covid by eliminating service guarantees is not going away any time soon. The "shipper's market" is here to stay.



## **PMAC Rate Analysis Notes:**

- 1. Carriers are continuing to discount heavier packages more because essentially the costs are the same; only incrementally higher at best.
- 2. Longer air zones are raised higher than shorter zones. Less regional and ground competition.
- 3. Residential deliveries are increasing due to less packages going to stores and directly to consumers.
- 4. Average package weights are decreasing also for this reason. We are seeing UPS expanding services such as Access Point and My Choice in an attempt to reduce the amount of possible residential attempts on deliveries.
- 5. Continual overlap in GDS and air services allow the carriers to keep the air services within GDS zones higher.
- 6. DIM factors need to be offset by standardizing box sizes. PMAC can help.

DIMENSIONAL FACTORS continue to have a tremendous impact on your shipment weight valuations.

Example: 2023 weighting for 35 X 13 x 25 package @166(Factor) = 68.52 lbs.

2024 weighting for 35 x 13 x 25 package @139(Factor) = 81.83 lbs. NET weight increase of 19.42%!

## **DIM Weight Rules – "The Weight of Air"**

UPS and FedEx in January of 2015 and thereafter have been redefining the laws of physics and declaring that "air has weight". It is surely a justifiable assertion when you are in the business of shipping toilet paper and paper towels; these items are large and bulky and take up more room in the line haul; this extra room could have been used for smaller and larger revenue generating parcels. However, if you are not in the business of shipping these items, the slap on the wrist may not be justified on your wrist. *Here's how it will work. See below:* 



Let's say this box is:

**12 X 10 x 8**, this would equal 960 cubic inches (CI). Cubic inches = length times width times height. Today for any ground packages shipped with UPS and FedEx that are less than 5184 CI will not be subject to dimensional weight pricing.

What is dimensional weight pricing?

Dimensional weight pricing is being billed for the higher of the dimensional weight of the package or the actual weight of the package. Dimensional weight is determined by calculating the cubic inches and then dividing by a "dimensional factor" or denominator. The current UPS and FedEx standard published DIM divisor (factor) is 139 on domestic packages.

So, back to our sample box (960 CI); divide the cubic inches by the standard published DIM divisor (139) and get 6.90 lbs. dim weight. This will get rounded up to 7 pounds as dimensional weight. Previous to the 2015 DIM Rules, this package would have gone out at the actual weight of the package. Since 2015, it will now be billed at the greater weight of the DIM weight or the actual weight.





## **FedEx/UPS Dimensional Rules Continue to Have a Significant Impact**

Continued Additional Handling and Large Package Surcharge Criteria have become extremely complicated. Please call PMAC to see how it affects you.

### **Additional Handling Surcharge**

- The additional handling charge for any U.S. Domestic package exceeding 50 pounds in actual weight will be assessed; previously 70 pounds.
- Demand Additional Handling Surcharges are debilitating and were supposed to be Covid temporary

### **Address Correction**

• The Address Correction charge will increase \$1.50. The per shipment maximum will increase \$10.50.

#### **Area Surcharges**

- The Delivery Area Surcharge applied to commercial addresses for Ground and Air Services will increase \$0.25.
- The Delivery Area Surcharge applied to commercial extended addresses for Ground and Air Services will increase \$0.45.
- The Delivery Area Surcharge applied to residential addresses for Ground Services will increase \$0.45.
- The Delivery Area Surcharge applied to residential addresses for Air Services will increase \$0.30.
